**Naya has been arrested for “illegal drug possession”!**

It would be very hard for any cat to admit that their favorite sibling or best friend would do something that could get them arrested. On the other hand, Mavis, Naya's least favorite sister feels somewhat differently. "Naya, Oh Naya," Mavis was saying, but it sounded more like she was talking to herself, "why did you have to do this? You know it could've only ended badly."

Sentencing for drug possession can be harsh when dealing with an illegal drug dealer or maker. If you are not in possession on any drugs at the moment, you can usually hope for a 6 month sentence. If you have been caught with some mild drugs, you'll be lucky to get a year. If you are in possession of some of the bad drugs (this is Naya's scenario), sentencing can be up to 3 years. If you commit the biggest drug crime of all - selling the worst drugs to unsuspecting buyers and telling them that they are "healthy", and there is a video or overwhelming evidence, you can get a life sentence in jail. Cats are rarely sentenced to that.

"This is the biggest crime we've seen in a while," a local police officer said during an interview with a reporter, just a little bit of proof about how serious this crime actually is. Illegal drug possession will most likely give Naya a 24 to 36 month sentencing, so she will spend a long time in jail. This is very sad news to report, and it is very sad for Naya's family and friends.
